BEFORE AGE 18: Apply to DDA and DORS AGE 18: Apply for SSI and Medical Assistance

AGE 19: Explore post-secondary options

AGE 20: Contact, interview & choose your provider

*Note: All dates are approximate. Please keep frequent communication with your Service Coordinator and school transition contact to ensure timely access to services.

Final School Year

Before final school year starts/over the summer

- Apply for SSI and Medical Assistance, if not already completed
- Meet with your Service Coordinator to discuss transition planning
- Start gathering important information- birth certificate, SS card, school records, medical records
- Talk to your SC about what information is needed

SEPTEMBER

OCTOBER

NOVEMBER

After school starts/September-November

- Invite your SC to the IEP meeting
- Attend local transition events- ask your school or SC for specific information
- Meet, interview, visit at least 3 providers
- Start filling out the provider application(s)

DECEMBER

Before the Christmas/Winter Break

- Select 1 provider (and a back up) and tell your SC and school transition contact
- Start gathering waiver financial documents over the break ask your SC for more information

JANUARY

FEBRUARY

MARCH

After the New Year

- Apply for the waiver, provide needed financial documents to your Service Coordinator
- Provide needed information to your chosen provider (i.e. medical information, ID, SS card) talk to your chosen provider for more information
- Share with your chosen provider/SC if you plan to start later services later than July 1st
- Ask your SC about transportation options- apply for mobility/paratransit, if needed

APRIL

MAY

Around Spring Break

- Review your Service Funding Plan

JUNE

GRADUATION!

After Graduation

- Services will start on or after July 1st, depending on funding and submission of all documentation
- Attend Individual Plan meeting 30 days after services start to determine goals for the upcoming year
